LOT 3: This is the largest segment of the collection, covering Scott #1 through #71. Major emphasis on First definitive Issue with between one and 32 examples of each denomination in mint and MNH and three to 15 examples in used condition, plus a few mint and used blocks of four (\$1,830.15 CV); plus about 50 sets of the 1946 Peace issue plus plate blocks, and blocks of 10. Also several blocks of four used. CV of Peace is about \$150. Silver Wedding has mint and used, total of four sets plus about 30 low value singles (\$280 CV). Another envelope with 21 MNH sets of Silver Wedding (\$934.50 CV). Also, quantities of Scott #20-21 mint, used, shades and blocks (CV is \$1,510.05). Scott #39-51 definitives in quantities up to about 15 of each denomination, plus mint and used blocks of four (\$434.00 CV). Many others of this period including full sheet of Scott #39 MNH. Total CV on this lot is about \$7,403.25. EST= \$1,110++ (that's 15% of CV!)
